On _____, 20_____, I have been issued Zoning Permit No. PZ_____ by Park Township for the construction of a building on the Property which will be used for agricultural purposes only as provided in the Park Township Zoning Ordinance and in State of Michigan law. It is therefore understood and represented to be true by the owner that:

A. The accessory building is for the storage of agricultural equipment and products which are incidental to the agricultural use of the land on which structure is proposed to be erected.

B. No portion of the accessory building is to be used for retail trade.

C. No portion of the accessory building is to be used for the storage of personal property that is not related to the agricultural use of the land on which it is located. No personal machinery, equipment, travel trailers, recreational vehicles or automobiles will be stored within the building and any such storage shall be at the owners' own risk because the Township has not authorized or inspected the accessory building for the same. The owner will not allow anyone other than immediate family members, agricultural employees, and authorized agents, if any, access to the accessory building.

8. I understand this building will be exempt from the State of Michigan Building Code because of its status as a building used for agricultural purposes only. I further understand that exempt status will be lost if this building is used, in whole or in part, for any other purpose except agricultural purposes. In that event, the building will be required to comply with the State of Michigan Building Code.

9. I agree that Park Township, at reasonable intervals and at reasonable times, may periodically inspect the building to determine if it is still being used for agricultural purposes only.

10. I understand that this Affidavit will be filed by Park Township with the Ottawa County Register of Deeds, and will continue to apply to the Property, regardless of who owns the Property.
