## a. Evaluating Consultants for Former Airport Property Visioning Process

#### b. Reviewing Supervisor's Draft Letter to EGLE for The Reserve on Lake Macatawa

The Board wanted to clarify the position of the application and if any changes have been made.

The Board agreed to insert additional language specifying navigation and safety concerns within Pine Creek Bay and to clarify to EGLE the applicant has notified the Township they have withdrawn their request for transient slips in their application to EGLE. Also, change the wording from extensive structural request to only structural request.

Gerard stated the distance of the slips into the bay is related to sediment on the bottom of the bay. The area cannot be dredged and to allow boats to safely be in the water, the

Fink stated the applicant has removed the cleats on the end of the dock in their proposal. The actual formation of the dock is the same as it was on the original application.

Motion made by Trustee Spoelhof and seconded by Treasurer Steggerda to proceed with the letter to Joshua Crane at EGLE as written by the Supervisor with the changes listed regarding inserting additional language specifying navigation and safety concerns within Pine Creek Bay and to clarify to EGLE the applicant has notified the Township they have withdrawn their request for transient slips in their application to EGLE and change the wording in the 3<sup>rd</sup> paragraph from "extensive structural request" to structural request.
