## REGULAR BOARD MEETING

## NOVEMBER 12, 2020

## ART 1. CALL TO ORDER

Supervisor Hunsburger called to order the regular meeting of the Park Township Board held on November 12, 2020 at 6:30 p.m. at the Park Township Office, 52-152nd Ave., Holland, MI 49424.

a. Proposed Amendment to North Beach Sub-area of the Master Plan and Revision to Future Land Use Map

 The Board discussed the zoning and what would be permissible under the current zoning

MOTION MADE; MOTION SUPPORTED; MOTION CARRIED: A motion was made by Keeter and supported by Steggerda to support the Planning commission recommendation for denial. (7-0)

c. Timberline Woods – Final Preliminary Plat Drainage Approval Fink requested the item be revised as a 1-year extension due to the newly enacted tree preservation ordinance. Because of the new ordinance, the Board would like to ask the applicant to sit down and review the ordinance and find opportunities for a positive impact on the development while taking into account the new ordinance.

**MOTION MADE; MOTION SUPPORTED; MOTION CARRIED:** A motion was made by Steggerda and supported by Nestel to approve the preliminary plat approval including working with staff to implement the tree preservation ordinance. (7-0)

d. MAX Transit Contract

Elisa Hoekwater – Executive Director of Max Transit, presented a PowerPoint to the Board. She broke down ridership, destination and pick up location around the township.

It is the Townships desire to continue with the Reserve-a-Max but not ask the voters to approve a millage for the required .4 mils. Hoekwater gave estimated costs for Reserve a-Max demand response and Full membership on the Max Authority Board.

Fink requested an extension to iron out details and wording of a contract.

Steggerda asked if the Township could ask for a millage to cover the much reduced costs of the Reserve-a-Max instead of asking for the .4 mils to join the Max Authority Board. Martin will research the idea and return the information to Fink.

- h. Election Worker Hazard Pay Keeter introduced the item and explained the reason for the hazard pay.

MOTION MADE; MOTION SUPPORTED; MOTION CARRIED: A motion was made by Gerard and supported by Steggerda to approve hazard pay in the amount of \$200 for each poll worker and \$500 for senior staff. (7-0)

#### ART 11. DISCUSSION ITEMS

- a. South Side Kayak Park and Fence Issue discussion and possible action
  - The Manager is asking for Board direction on modifications in the fence structure along the western side of the property. The increased cost on the contract is \$8000 to make the modifications.
  - The Board agreed the entire fence should be a 4' white picket fence.
- b. Quit Claim Deed for 10 acre Chamber of Commerce property
  Hunsburger and Martin explained the legality of the reversion clause
  pertaining to the 10 acre Chamber of Commerce parcel on the airpark
  property. Martin gave a written legal opinion and all Board members
  received an email regarding that opinion. The understanding of Mr.

Martin is the 10 acre parcel is no longer being used for airport services.

The Board discussed the ramifications of signing the Quit Claim Deed and if they would like to hire another attorney, Bob Buchanan, to give his legal opinion regarding the property.

The Board agreed to hire Mr. Buchanan to give a legal opinion on this topic.
