There will be a public hearing before the Board of Trustees of Park Township, Ottawa County, Michigan **via Zoom** consistent with the Open Meetings Act and the most recent Michigan Department of Health and Human Services Order, on **Thursday, March 11, 2021, at 6:30p.m.** or thereafter for the purpose of considering a major amendment to the Macatawa Legends Planned Unit Development.

**Section 1**

*Hearing*

A Final Planned Unit Development Plan from GRR7 Land Investments, LLC to perform a major amendment to the existing Macatawa Legends Planned Unit Development to create 54 single-family lots on an existing private road as well as establish a new private road serving four single-family lots for a total of 58 single-family lots. The property is approximately 155.8 acres in area and is currently zoned within the Agricultural and Permanent Open Space District and the Planned Unit Development Zoning District.
